

**And**

**SARVODAYA SHIKSHAN MANDAL'S SAU. LEENA KISHOR MAMIDWAR INSTITUTE OF MANAGEMENT STUDIES & RESEARCH, Kosara Road, Chandrapur** represented by the **Principal**, shall unless excluded by or repugnant to the context, include its successors and assignors, representatives of the **SECOND PART/ Party**. The first party & the second party believe that joint collaboration between MITCON Consultancy & Engineering Services Ltd. & Sarvodaya Shikshan Mandal's Sau. Leena Kishor Mamidwar Institute Of Management Studies & Research, Kosara Road, Chandrapur for conducting various skill based vocational training programmes under various Central and State Govt Schemes, will promote more effective use of each of their resources, and provide each of them with enhanced opportunities.

**Objective of the MoU**

- Development of skilled manpower required as per the norms of the industry.
- Optimal utilization and development of available resources.

**Role of the MITCON**

- MITCON will act as bridge between University, College, Students & Industries for development of skilled manpower.

- Mobilization of students for various courses.
- Overall coordination & Monitoring of Training programmes.
- Imparting Entrepreneurial & Soft skill inputs.
- Conduct examination i.e. assessment of participants & provide certification after completion of the course.
- To Liaison with concerned departments & Industries for successful placement of the trained participants.
- Hand holding support to participants as & when required.

#### **Role of the College**

- Providing necessary infrastructure & laboratory support for classroom & practical sessions.
- Providing Canteen & hostel facility in case of residential training programmes.
- Technical faculty support if required.
- Assistance in designing need based course module & course material.
- Assistance in advertisement of training programme.

#### **Payment Terms**

Amount payable to the institute for hiring their infrastructure facilities should be decided mutually in writing on case to case basis and shall be payable after completion of the programme or as per the terms mutually agreed by both the parties.

#### **Term of the MoU**

#### **Force Majeure**

Neither party shall be accountable for any delays or non-performance directly or indirectly resulting from circumstances or causes beyond its reasonable control including without limitation acts of any law & order or requirement of any government agency or authority.

#### **Confidentiality Undertaking**

Both the parties agree to use their best efforts to maintain in confidence the existence of this MOU, the contents and terms and consideration for this MOU. Each party hereto agrees to take every reasonable precaution to prevent disclosure of any information to third parties, except for disclosures required by law or by virtue of any agreements entered into by the company of necessary to effectuate the terms of

this MOU. The parties agree to take every precaution to disclose the contents and terms of this MOU only to the persons who have reasonable need to know of such information.

### **Governing Law & Dispute Resolution**

- a. This MOU shall be governed by the prevalent laws of India.
- b. All disputes, controversies and differences arising among concerned parties out of or relating to this MOU, including any dispute relating to the validity or existence of this MOU/ Letter of Cooperation ("Dispute") shall be solely referred for arbitration under the provisions and Conciliation Act, 1996 and its amendment or re-enactment thereof.
- c. The arbitral proceedings shall be conducted by the sole arbitrator who shall be a person from the list of panel of Arbitrators published by Hon'ble High Court, Bombay, and shall be based in Pune who shall produce Final and binding award within six(6) months from the date of the appointment of the arbitrator. Both the parties shall co-operate with and assist the arbitrator to complete arbitration proceedings within this timeframe.
- d. The arbitral award passed by the arbitrator shall be final and binding on the Parties and shall be enforceable in accordance with its terms. The arbitrator shall state reasons for its findings in writing. The parties shall agree to be bound thereby and shall act accordingly.
- e. The seat of arbitration shall be at Pune, Maharashtra.
- f. Arbitral proceedings shall be conducted in English language.
- g. This Clause shall survive any termination or expiry of the term of this MoU

### **Termination**

- a. The MoU can be terminated by either party by giving the other party, a prior written notice of not less than one month of its intention to do so but without dishonoring any commitment entered into prior to the date of termination notice and no party shall leave its commitment unfinished which may result in tangible losses to the other party.
- b. This MoU shall also stand terminated for any reason such as legal processes, acts of the State of similar such exigencies beyond the normal control of any party concerned and which disable any of the parties hereto from functioning further.
- c. The MoU may be terminated by both the parties by mutual consent without any prior notice
- d.
