The closing cash-in-hand balance of Rs. 2314.50 is as per the Cash Book produced before us.

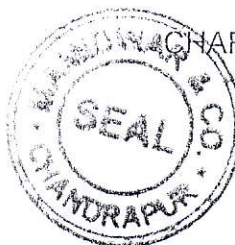

The closing cash-in-hand balance of Rs.8810.50 is as per the Cash Book produced before us.

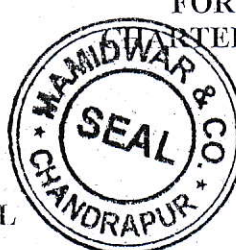

And in our opinion and according to information and explanation given and to us the accounts shows a true and fair view.

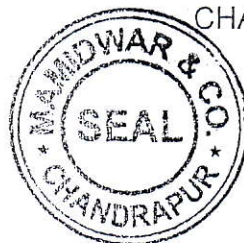
